### Subject: European Maintenance Manager Award (EMMA) - General Rules Competition

Dear General Assembly members,

Please find below information about the European Maintenance Manager Award (EMMA) competition. This competition is a bi-yearly activity. It's one of the EFNMS objectives to promote the awarding of prizes and distinctions relating to maintenance. The Award is sponsored and supported by the Salvetti Foundation.

# A. <u>Duration of registrations</u>

The registrations for the Competition will start on the  $15^{th}$  of April 2020 and will be closed on the  $30^{th}$  of November 2020.

#### B. <u>Participation terms</u>

Participants in the EMMA competition undertake to complete the report/questionnaire truthfully. Participation is open to employees of maintenance departments, engineering departments and experts of service providers in the field of Maintenance and Maintenance within Facility Management organisations. Nominations are made only by the 24 EFNMS Member Societies.

## C. The jury

A jury of 5 international maintenance experts evaluates the reports. Including the EFNMS chairman and 2 nominated NMS members. The president of the Salvetti Foundation will act as chairman of the jury. Reports should be sent to the fifth member of the jury, the general secretary of the Salvetti Foundation. He shall take care of the report distribution to the jury members and chairman.

## D. Procedure

The competition is conducted in the following steps:

The announcement of the winner will be made during EuroMaintenance congress in Rotterdam.

The winner will receive the diploma, "European Maintenance Manager 2021" during a special EuroMaintenance dinner. He / She will be invited by EFNMS to attend EuroMaintenance on the date of the award ceremony.

#### Extract from Salvetti Foundation website.

The nominee shall present to the jury the following documents and/or information:

- \* An actualized Curriculum Vitae, showing the various stages in his/her education, training, and work experience.
- \* In the case of a maintenance manager on an industrial environment, a clear description of the role of the maintenance department and of the nominee in the whole of the organization/company he/she is employed in, with special emphasis on the role in investment procedures. If applicable a list of publications or presentations in public forums.
- \* In the case of an educational or research institute a list of publications or presentations in public forums and a clear picture of developments in the field of maintenance initiated or directed by the nominee.
- \* In the case of a consultancy environment a clear picture of projects initiated or directed by the nominee, indicating the results of said projects.
- \* All information delivered to the jury shall be in digital form and in the English language. For publications the title, the foreword and the ISBN number will suffice. For presentations the title, summary and the name and year of the occasion (conference, symposium, or the like). All information shall be directed to the secretary of the jury.
